## ALDA Governing Board Elections 2020

### 1. Statutory framework

#### Article 15 - The Governing Board and the Bureau

a) The Association shall have a Governing Board, called the LDA Board, composed of nine to fifteen members:

- - The member appointed by the Secretary General of the Council of Europe;
- - The President of the Congress or his or her representative;
- - The Chair of the LDA Delegates' Advisory Committee.

Between six and twelve active members shall also be elected to the Governing Board by the General Assembly for a period of four years ensuring, as far as possible, the representation of towns and regions hosting LDAs as well as a geographical balance. Outgoing members may be re-elected. [...]

The grant making initiative was implemented in cooperation with the Bosch Foundation from Germany. Initiator of the LDA in Dnipro, Ukraine establishment, which was opened in 2015. For the initiative to open the LDA in Dnipro, he was awarded the Honorary Award of the Chairman of the Dnipropetrovsk Region Council. The initiator of joining the ALDA of the Lower Silesia region and the city of Wroclaw - the capital of the region. He is fluent in English, German, Russian and Ukrainian.

### Ideas for the activities in ALDA Governing Board:

1. Support the activities of the network in the Eastern Partnership countries. Especially developing the LDA network in Ukraine. There are currently two LDAs in this country in Dnipro and Mariupol. A country as large as Ukraine has the potential for more LDAs. At the same time, Ukraine is conducting a decentralization process involving the transfer of competences and finances to the lower levels of local government and needs cooperation with partners from the EU in this regard. Let us hope that soon there will be also opportunities for open cooperation with local governments and civil society in Belarus. ALDA is currently working with partners in Belarus. This cooperation should be continued and developed. Especially in the context of the increase in civic activity in Belarus after the last presidential election in August 2020. Development of cooperation with partners from the civil society sector and local governments in Russia and Central Asia.
