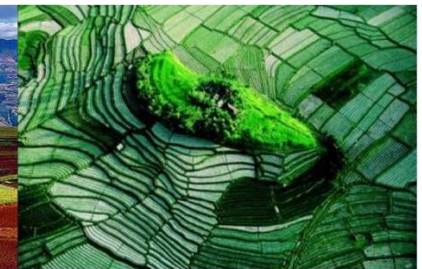
WHAT WE OFFER

LEARNING ENVIRONMENT

We offer you **Master Degree course (120 ECTS credits)** in two academic years. All our course units and educational activities are offered in the seven participating universities through a specific **mobility scheme** for the students: each participant will study in at least 3 different countries

ADMISSION REQUIREMENTS

STeDe Master course is open to non-EU and EU candidates. We welcome students with:

- **Bachelor degree** or equivalent (min. 180 ECTS, 3 years of study)
- a good command of **English** and **French**, both spoken and written
- a **strong motivation and personal interest** in sustainable development
- a basic knowledge of economics will be appreciated.

RELEVANT DATES

1. Submissions are due by **January 31st 2017**
2. Pre-selected candidates will be notified and a skype interview will be fixed by **March 15th 2017**
3. All selected students, students on the reserve list and not selected will be notified by email by **April 30th 2017**

TUITION FEES

The participation costs/"tuition fees" for Erasmus + scholarship holders:

- **4,000 Euros/Academic Year (EU Applicants)**
- **7,000 Euros/Academic Year (for non-EU Applicants).**

For Erasmus+ scholarship holders (all categories) all participation costs (fees) are covered by the scholarship.

ERASMUS+ SCHOLARSHIPS

Every year about **20 scholarships** are expected to be available for non-EU and EU students.

Erasmus+ Scholarships amount to **24,000 Euros for the whole study** programme (Monthly allowance).

In addition, support to the travel and installation is provided according to the candidates' category (EU or non-EU students) .
