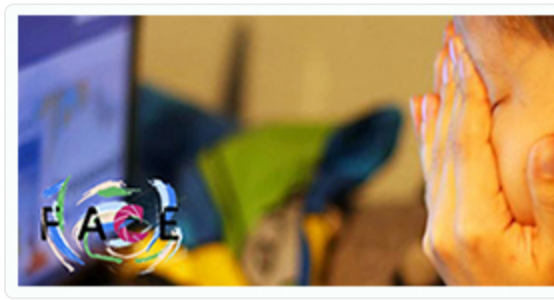

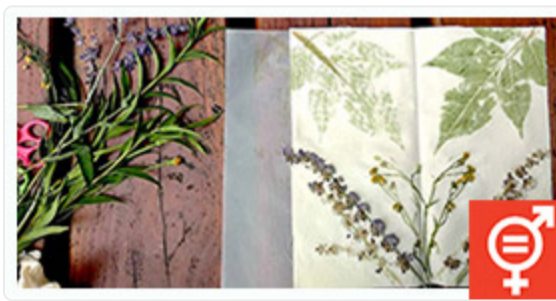

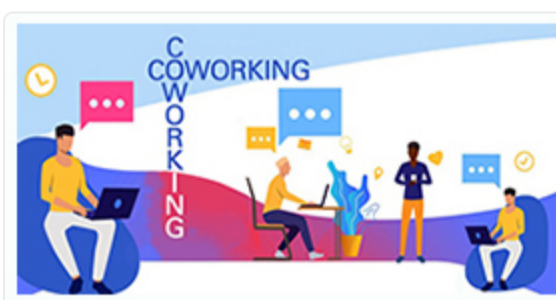


MIND INCLUSION 2.0 IN ACTION WITH PEOPLE WITH COGNITIVE DISABILITY
