



#### Learning from the past

#### **YOUTH programme (2000-2006)**

- 380.000 participants in youth exchanges
- 20.000 EVS volunteers
- 8.000 Youth initiatives

•

Total: 700.000 participants in 70.000 projects!





#### Youth in Action 2007-2013

- Budget: 885 millions €
- Decision of the Council of Ministers and European Parliament 15
   November 2006: Programme officially adopted





#### **Objectives of the programme**

- Promoting young people's active <u>citizenship</u>;
- Developing <u>solidarity</u> to reinforce social cohesion in the European Union;
- Fostering mutual <u>understanding</u>
- Contributing to developing the quality of <u>support systems</u> and the capabilities of <u>civil society</u> in the youth field;
- Promoting European cooperation in youth policy.

#### Non-formal and informal learning


#### **YOUTHPASS**

Every person who has taken part in a Youth in Action project under Action 1.1, Action 2, and Action 4.3 receive a Youthpass certificate, which describes and validates the non-formal and informal learning experience acquired during the project.





#### How is the programme implemented?





#### Who can participate?



In general: young people from 15 to 28

But:

-Youth exchanges: 13-25 (exception: 26-30)

-Youth initiatives: 18-30 (exception: 15-17)

-Youth Democracy Projects: 13-30

-European Voluntary Service: 18-30 (exception: 16-17)

-Training and cooperation: no age limit, and includes other actors involved in the field of youth and non-formal education



#### Participants and target groups



Youth in Action projects are submitted and, if selected, managed by *promoters* representing the participants.

#### **Eligible promoters**

- non-profit or non-governmental organisation
- local, regional public body
- informal group of young people
- body active at European level in the youth field (ENGO), having member branches in at least 8 Programme Countries
- international governmental non-profit organisation
- •a profit-making organisation (only when it organises an event in the area of youth, sport or culture).

legally established in one of the Programme or Partner Countries

### Programme Guide: permanent call for proposals

Decentralised level:

5 deadlines each year:

- 1 February
  (Projects start between 1 May and 30 September)
- 1 April

(Projects start between 1 July and 30 November)

1 June

(Projects start between 1 September and 31 January)

1 September

(Projects start between 1 December and 30 April)

1 November

(Projects start between 1 February and 31 July)

Centralised level:

3 deadlines each year:

- 1 February
- 1 June
- 1 September

+ Specific calls for proposals

#### **Action 2: European Voluntary Service**



■ The aim of the European Voluntary Service is to support young people's participation in various forms of voluntary activities, both within and outside the European Union.

## Sub-Action 4.3 decentralised action: Training, Exchange and Networking in the youth field

- Two general Objectives:
  - Promoting exchanges, cooperation and training in European youth work
  - Supporting project-development under the Youth in Action programme
- Eligible Activities: Job shadowing, feasibility visits, evaluation meetings, study visits, partnership-building activities, seminars, training courses, networking
