INTRODUCTION

The idea of the project RECOV originates from the awareness and recognition that nowadays in European societies, local authorities are the developers and implementers of sustainable and inclusive local development policies. Thereby, both local and most importantly European issues have to be taken into account and put in synergy. Therefore, the project targets local authorities, citizens and communities for creating local networks capable of working together on the improvement of local governance through dialogue and participation, contributing to more inclusive and democratic society.

Through involving citizens and local authorities, it helps to foster the exchange of best practices of local cooperation as well as to share solutions contributing to the establishment of learning networks on European level. Capacity building activities, discussions on EU contribution to local policies and initiatives as well as ways and tools for their improvement contribute to fostering European citizenship and improving conditions and democratic participation at Union level.

While seeking to effectively respond to local challenges, the project suggests new and collaborative service approaches taking into consideration limited governmental resources and recognizing the importance of each specific local actor (NGOs, SMEs and etc.). Along with networking exercises at local level it encourages the development of "co-" services creating synergies of expertise and allowing to find the most sustainable solutions. Through sharing best practices, partners can profit from each other's solution to local problems and gain support during the implementation phase.



Moreover, the project will raise awareness on EU policies in relation to those societal challenges as well as on mechanisms for addressing them both at local and European level. It will foster debates and discussions on what is being done politically and what can be improved along with development of concrete recommendations during the joint international event.

These recommendations will be a result of bottom-up activities implemented during the whole implementation period of the project based on the inputs from local actors and LAs and put together by the Network of towns created within the project. By participating in the project activities at local and international level, citizens will improve their understanding of the policy making process in the European Union as well as learn ways to engage and influence them.

The present document summarises the challenges that the local authorities and the CSOs face while cooperating in collaborative values for public services.



WHAT IS RECOV?

The RECOV project was developed by 10 partners across Europe, recognizing the importance to jointly address recently emerging challenges and to take an advantage of opportunities arising out of this cooperation. It aims at creating a network of towns eager to work together on exchanging common problems, joint brainstorming and introducing concrete measures in regard to project specific objectives.

First of all, the project deals with the problem of lacking communication and dialogue between governments and citizens fueling mistrust and passiveness of civil society. To address this challenge, the project suggests the usage of recent ICT instruments to "opening" up the work of governments through participatory policy- making and evaluation of policies and programs, while enhancing transparency and accountability.

Second, the project fostered discussion among local governments on existing financial instruments, EU policies and possible EU support to local problems as well as alternative fundraising. Third, the project acknowledges the failure of unilateral approaches to problem solving. Therefore, the project suggested collaborative approaches that bring together local stakeholders from various fields of expertise and putting in synergy their knowledge and competences for public good.

- Realized 4 traineeships for 6 months aimed at young graduates through an agreement with the University of Cagliari and the regional agency work. The traineeship was finalized to the implementing of the public administration procedures;
- Has participated to the notification named LAV- ORA, financed by Sardinia Region. There have been 119 applicants by beneficiaries and 4 beneficiaries have worked for a year, in different public bodies;

FIRST INTERNATIONAL EVENT "OPEN-GOVERNMENT: PRINCIPLES, METHODS AND ICT OPEN SOURCE TOOLS" 26 - 28 JUNE 2018

SKOPJE, THE REPUBLIC OF NORTH MACEDONIA.

The first international event focused on ICT tools for open government. The objective of the event was to present good practices on the use of ICT tools for open government with a focus on new technologies.

The participants learned about the meaning of open government and digital tools to foster citizen participation through different activities. The event included open conference, workshops and debates for raising awareness on the importance of new technologies in the work of the public institutions. In addition, the event included a study visit to the Department of cooperation with the NGOs in the City of Skopje.

Recommendations and Conclusions

Open government is defined as a "governing doctrine which holds that citizens have the right to access the documents and proceedings of the government to allow for effective public oversight." Open governance is fostered through transparency, civic engagement, access to information and service delivery enabled by the governing bodies.

SECOND INTERNATIONAL EVENT "COLLABORATIVE PUBLIC SERVICES: BUILDING AND MANAGING OF PUBLIC CO-WORKING SPACES AND CO-HOUSING" 16 -18 JANUARY 2019, SANTORSO, ITALY

The second international conferences focused on the topic of building and managing of public co-working spaces and co-housing. The main objective was to share practices and tools that allow municipalities to be more open, while focusing on involving actively the local communities in collaborative activities.

During the conference, the panellists shared their experience about co-working and co-housing, thus opening a discussion on why and how local communities should engage in the practices of co-working spaces and co-housing. Furthermore, several regional co-working initiatives were presented, such as Megahub, Spazio Hub and Urban Center Thiene.

Recommendations and Conclusions



THIRD INTERNATIONAL EVENT "INNOVATIVE AND SUSTAINABLE FINANCIAL INSTRUMENTS FOR LOCAL GOVERNMENTS" 21 - 23 OCTOBER 2019 LISBON, PORTUGAL

The 3rd international conference was organized with a special focus on EU rules and mechanisms and on new sustainable financial instruments for public authorities in response to the economic crisis. The event aimed at debating about the financial instruments that allow municipalities to be more inclusive, dealing with the economic crisis thanks to involvement of citizens and to collaborative actions.

The event was structured around a number of thematically-focused sessions during which participants present their work and had the possibility to learn more about the topic.

Recommendations and Conclusions

In this particular context, socially responsible investment can make public financing more efficient. The local governments would need to increase the capacity of local authorities and make determined efforts to deal with local development challenges

FINAL INTERNATIONAL EVENT "PARTICIPATION AND COLLABORATIVE VALUES AS A WAY TO INNOVATION AND LOCAL DEVELOPMENT" 19 - 21 FEBRUARY 2020 BRUSSELS, BELGIUM

This fourth international gathering was the latest in a series of international conferences. The conference focused on collaborative values and rules to boost solidarity and innovation in local communities and on active citizenship through the presentation of best practices, tools, methods and EU funds to sustain the participative process.

Recommendations and Conclusions

Civic participation has a direct and indirect impact on the quality of life and attitudes of the population towards national and local government. Therefore, the availability of information resources, the social media play an important role.







Local paths

The International events within the RECOV project were followed by local activities ensuring continuity and the transferability to the local level. The methodologies used for organizing the local activities was the participatory approach including analysis, discussions and working groups. The local events provided inputs for joint international events, encourage debates, and stimulate actions and new ideas based on lessons learnt from European partners for implementation of interventions and pilot actions at local level.

Each local path is implemented by all project partners in their local community in order to raise awareness on the corresponding topic and support the role of grassroots organisations and local authorities for development. The development dimension of each thematic path targets different local stakeholders such as institutions, schools, private sector and citizens.

The participants in each local path had the opportunity to learn, discuss, exchange views and present best practices. The local activities also represented an opportunity for citizens and local authorities to reflect on the examples of best practices and recommendations for the future of the community.
