# Introduction

**ALDA - the European Association for Local Democracy** is an organisation dedicated to the promotion of good governance and citizens participation at the local level. ALDA in particular focuses on activities that facilitate **cooperation between local authorities and civil society**. Everyday, we develop projects with our members to support their activities for the good of the whole community.

ALDA was established in 1999 at the initiative of the Council of Europe's Congress of Local and Regional Authorities and has now established cooperation with the European Commission and the Committee of the Regions.

ALDA is funded through membership fees and project funding from the European Commission, the Council of Europe and other public and private donors.

ALDA is a membership-based organisation gathering **300 members** coming from almost **40 countries**. ALDA members include **local and regional authorities, associations of local authorities, non-governmental organisations, civil society organisations and academic institutions**.

Besides members, ALDA Community counts 6 offices 15 Local Democracy Agencies in Neighbouring Countries. Activities of ALDA, following the ambitious aim of "**going global**", now cover countries in sub-saharan Africa and Central Asia.







# What we do

## **ALDA conducts its activities through actions:**

- Developing and managing its own projects (and members' projects) in the field of good governance and citizen participation advocating towards the implementation of the Agenda 2030 at the local level;
- Coordinating and supporting the 15 Local Democracy Agencies and 2 Operational Partners;
- Cooperating as official partners of the Council of Europe and the Congress of Local and Regional Authorities. Working as long-term partner of the Europe for Citizens Programme and Citizens, Equality, Rights and Values Programme and other key policies and programmes of the European Commission;
- Leading advocacy and lobbying activities raising the voice of its members and partners to orient local, national and European policies in our field of activities to make a stronger and more cohesive Europe and neighbourhood.

**ALDA works through a participatory approach and the method of multilateral decentralised cooperation, always focusing on strong partnerships between Local Authorities and civil society organisations.**

## **PROJECTS DEVELOPMENT AND FUNDING OPPORTUNITIES**

Based on members' eligibility, priority on opportunities offered to be partner of projects, or to join consortia built to apply for tenders in various fields.

Support of ALDA multilingual staff in the project proposal development phase (EN, FR, IT, SR, MK, RU) and in finding project partners among the members' network of ALDA

Access to subgrant opportunities in the framework programmes of ALDA (in 2023, within ALDA's Operating Grant of the CERV programme, 15 members of ALDA were granted a total of 185,000 €)

## **BEING PART OF A CONSOLIDATED INTERNATIONAL AND EUROPEAN NETWORK**

Support in relations with the institutions of the EU and the CoE representing local authorities, with local and regional authorities, and National Governments in the enlarged Europe

Visibility through a European network counting hundreds of members, projects' partners and citizens impacted by the activities of ALDA

Promotion of members' activities, initiatives and events through ALDA's communication channels (newsletter - 11.000 contacts, website - 200.000 visitors/ 1.300.000 visits per year, social networks, media activities)

Online presence on ALDA website and presentation to the network of contacts via the newsletter

Networking opportunities during events organised by ALDA (annual General Assembly and Festival, international conferences, projects' activities, etc.) and in partnership with the European institutions

Free use of ALDA equipped offices and meeting rooms in Brussels (Belgium), Vicenza (Italy), and upon approval of the Council of Europe, in Strasbourg (France) for ad hoc meetings

Information on funding programmes and opportunities (training sessions and dissemination of information)

Participation in international events (conferences, seminars, webinars etc.) promoted by ALDA on good local governance, project management and development, communication

Access to the Thematic Hub services: targeted call for partners, thematic training sessions, participation to events, dissemination of publication and papers

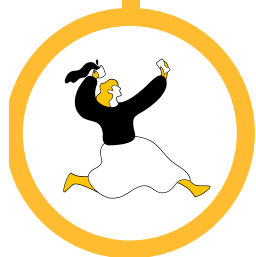
## COPY OF BUDGET

The documents are to be sent to [membership@alda-europe.eu](mailto:membership@alda-europe.eu)

Memberships are approved on a continuous basis, usually every two months, by ALDA's Governing Board. The candidates will be requested to present their application in an **online meeting** after which the Board will decide the membership status. The applicant is considered a full member of ALDA once the applicant receives the formal approval from ALDA's Governing Board. The member will then access the services of ALDA and will be able to vote at the General Assembly. The new member will receive the instructions for payment of the fees. The membership fee is calculated on the basis of your Association/Organisation/Municipality's last approved budget, to assure all our members a fairer fee allocation and enabling smaller organisations to join ALDA and enrich our network.
