About the project

The BRIDGE to the CoE — BuildingResilience and Independence for Democratic Governance and Engagement with the Council of Europe — is a European initiative led by ALDA to combat democratic backsliding by strengthening civil society participation. Focused on both Southern and Eastern Europe, the project enhances citizens' engagement, fosters dialogue, and builds capacities to ensure democratic resilience. It leverages ALDA's extensive experience and partnership with the Council of Europe to bridge civil society and democratic institutions, fostering trust, participation, and active governance.

Objectives

- Increase awareness about the role and standards of the Council of Europe in promoting democratic governance and enhancing civil society representation.
- Foster dialogue on the evolution of civic space and the challenges to democratic resilience in Southern and Eastern Europe.
- Enhance civil society capacity to participate in Council of Europe processes and engagement opportunities.
- Build connections between civil society, public authorities, and institutions to promote citizens' active participation in governance.

Challenges

Across Europe, democracy is under strain due to declining civic engagement, rising populism, polarisation, and erosion of the rule of law. In Eastern Europe, countries like **Moldova and Ukraine** are working to strengthen democratic institutions amid conflict and societal division, while civil society faces legal restrictions and political pressure.

In Southern Europe, even long-established democracies such as **Italy** are seeing a shrinking civic space, where NGOs—especially those focused on human rights and migration—face bureaucratic hurdles and institutional disengagement.

These challenges reflect a continent-wide democratic backsliding. To counter this, there is a pressing need to empower civil society, boost citizen participation, and uphold Council of Europe standards.

The "BRIDGE to the CoE" project responds to this by raising awareness, fostering dialogue, and enhancing civil society's capacity to engage in democratic processes.
